# Regional Assembly, Lisbon

Co-operative enterprises have a significant role to play in helping to create a more competitive and dynamic Europe. This was the conclusion of the Regional Assembly and Seminar held in Lisbon, 10-11 October. A highlight of the event was the presence of Mr. Erkki Liikanen, European Commissioner in charge of Enterprise and Information Society. In his keynote address he considered co-operatives as bridges between communities and global economies. With the increasing share of electronic commerce, he feels that co-operatives have an even better chance to obtain the confidence of consumers. In this context he encouraged co-operatives to use dot coop. He confirmed the recent supportive measures of the European Commission, in particular to the adoption of the Statute for a European Co-operative Society (ECS) and the official communication under preparation on the promotion of co-operatives. Mr. Liikanen invited ICA Europe and its member organisations to help the Commission's efforts in raising and increasing awareness of co-operative success and good practice.

Presentations made at the Seminar included: "The ILO Recommendation 193 on co-operatives and its implementation" by Jürgen Schwettmann, Chief, ILO Co-op Branch; "The Statute for a European Co-operative Society: Easier co-operation across borders" by Daniela Cario, DGRV, Germany; "Enlargement — What impact on co-operatives?" by Jerzy Jankowski, President, National Co-operative Council, Poland; "Dot.coop fostering co-operative enterprises" by Jean-Claude Detilleux, President, GNC, France; "Co-operatives in Enterprise Europe" by Francesco lanniello, Head of Unit, DG Enterprise, European Commission and the "Statement of the ICA Europe Youth Seminar". The three member organisations of ICA, Fenacoop, Inscoop and Confagri, were hosts to the 300 participants of this successful Assembly. Mr. José Luis Arnaut, Deputy Prime Minister addressed the Assembly on behalf of the Portuguese government.

At the invitation of the National Co-operative Council, the next Regional Assembly will be held in Poland in September 2004.

#### ∑ European Council

At their meeting in Lisbon on 9 October, the European Council received an excellent oral report from Pauline Green on the work of the ICA Board Task Force. Ivano Barberini, ICA President and lain Macdonald, Director General gave a comprehensive report on ICA global issues, which was On the proposal of Felice Scalvini, Vice-President of appreciated by the members. Confcooperative, Italy, members agreed to recommending the Regional Assembly to send a message to the European Convention asking them "to recognise the value and social function of co-operative enterprises and adopt appropriate measures to promote and favour the development of enterprises, whose structure and aims correspond to the co-operative principles".

The first meeting of the newly elected European Council was held in Manchester, on 16 December. On behalf of the Presidium Pauline Green, chairperson of ICA Europe drafted a proposal on Strategy, Procedures and Operations. The priorities suggested for the work of the Council over the next two years are: the strengthening of co-operative cohesion in Europe and the campaign to ensure that co-operatives are recognised as key players in the economy of each country in the region. Council members approved the paper and agreed to enlarging the Presidium (chairperson and two vice-chairs) with three more members, namely Galina Kiseleva, Russia, Petr Brozek, Czech Republic and Felice Scalvini, Italy. This new Executive intends to meet as necessary in order to drive forward the decisions made by the Council and strengthen relationship with all European members. The European Council decided also to draft a "regional response" to the ICA Board Task Force Report after having received the reactions of European members on the paper.

We encourage you to discuss the Executive Summary of the Board Report - circulated by the ICA Director General early November - with your members and send us your comments and suggestions as soon as possible.

The next meeting of the European Council will be held in Helsinki, 14 March 2003.

#### The Bosnia and Herzegovina

The Co-operative Association of Bosnia and Herzegovina has addressed an appeal for support to ICA members. Although the Government declared its support for co-operative development through adopting a new co-operative law, it has not allocated any funds or loans to accompany this. Therefore, any form of assistance in kind or project support would be appreciated, which would allow the National Co-operative Association to continue its activities aiming at the promotion of co-operative development in the country. We count on your solidarity.

#### **☆** France

Crédit Mutuel responded to a tender published by the European Commission concerning technical assistance to Georgia for the creation of a network of savings and credit co-operatives.

The Groupement National de Coopération (GNC) initiated a major research project with the aim of publishing a Directory of French Co-operators. The aim is to trace back the history of the French co-operative movement and pay tribute to the founders and key players.

# ☆ <u>Italy</u>

The main theme of the 36th Congress of LEGACOOP held in Rome, 28-30 November, was: "The Co-operative Project: Freedom and Security, Entrepreneurship and Participation". The Congress amended the Statutes of the organisation and sent a message to the President of the Republic urging the adoption of a new Co-operative Law. The 500 delegates attending the Congress elected Mr. Giuliano Poletti as its new President. Mr. Poletti was former Vice-Chairman of LEGACOOP and President of the Regional Union, Emilia Romagna.

Having served two terms of office as President of LEGACOOP, Mr. Ivano Barberini, ICA President was elected to a new post, Chairman of the National Assembly.

#### > Portugal

The co-operative sector in Portugal represents 5 per cent of the Gross National Product. Co-operatives are involved in agriculture, housing and retail trade as well as in providing social and cultural services. In the Republic's Constitution, co-operatives are mentioned as being an integral part of the country's social and economic development. The presentation of Manuel Canaveira Campos, President of INSCOOP, made at the ICA Regional Assembly for Europe, on the challenges for the Portuguese co-operative movement, is available in French from their Secretariat.

# $\stackrel{\wedge}{\bowtie}$ Russia

Parliamentary hearings on the subject "Essence and Role of Co-operation in the National Economy" were conducted on 5-6 December in Moscow. Members of the Parliament, co-operative leaders from all sectors, high-ranking government officials and decision-makers took part in the sessions.

Valentin Ermakov, Chairman of Centrosojuz's Council, stressed in his report, the important role consumer co-operatives play in the solution of the vitally important problems of Russian villages. He underlined the contribution of consumer co-operatives to creating jobs, providing loans for purchasing goods, maintaining 29.000 shops in remote areas, which is an unprofitable activity and assisting the sick, the poor and rural people, in general.

Other speakers emphasized that 57 % of the rural population were under the poverty line and the number of jobless people was close to two million. Youth were leaving the village and the countryside was becoming deserted. All speakers agreed on the vital role co-operatives can play in improving this situation and contribute to the development of national economy. Some speakers called the attention to tax legislation, which didn't take into account the social responsibility of consumer co-operatives and urged amendments to legislation in order to develop rural infrastructure and impede Russian villages to disappear.

# ☆ <u>Sweden</u>

KF – Kooperativa Förbundet has been reorganised. The new structure consists of the office of the President and CEO, Mr. Börje Fors and the four departments: KF Secretariat headed by Lars Hillbom, KF Co-op Society Contacts, KF Finance and KF Cards.



"Our new structure is tailored to KF's new duties", said Mr. Börje Fors. "KF's jobs now include operating as the national union of consumer co-operative societies in Sweden, and being the active owner of subsidiaries and associated companies. This applies specially to Coop Norden, our most important associated company." The new structure will also produce considerable costsavings.

KF is the principal owner of the associated companies Coop Norden AB, which includes Coop Sweden and Coop Bank AB. KF owns 42 per cent of Coop Norden, FDB Denmark 38 per cent and Coop NKL Norway 20 per cent. KF also owns 47 per cent of Coop Elektro AB.

#### √ United Kingdom

The Co-operative Group, Midlands Co-op and Oxford, Swindon and Gloucester Co-op have linked with Oxfam to make giving to charity easier. Shoppers will now be able to donate money as they pay for their shopping. The money donated will be used to provide clean water supplies in Africa.

The Co-operative Group has acquired the business of Alldays, one of the largest convenience store chains in the UK. The deal which adds over 600 stores to the Group's portofolio makes it the UK's leading convenience store operator.

As a result of a decision made by the UK Co-ops to switch its entire range of own brand chocolate to Fairtrade, UK sales of ethically-produced chocolate are set to double.

The deal which has been struck with the Ghanian cocoa co-operative, Kuapa Kohoo, will

- Guarantee a fair price for their cocoa harvest
- Provide vital services to impoverished communities
- Give much need support to the co-operative movement in Ghana
- Encourage other retailers to follow suit

#### **EUROPEAN COMMISSION AND PARLIAMENT**



#### Successful conclusion of enlargement negotiations

Negotiations were concluded with ten candidate countries, Cyprus, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, Slovakia and Slovenia, at the European Council of Heads of State held on 12-13 December in Copenhagen. They reached agreement on the formula for enlarging the EU to encompass ten new Member States as from 1 May 2004. The objective is to welcome Bulgaria and Romania as members in 2007. The European Union is ready to open accession negotiations with Turkey in 2004.

Out of the total of Euro 408 million, Euro 108 million will go to Poland, specifically for implementing the Schengen agreement on border controls. The rest will be split among the other new Member States.

The new Member States will receive a rural development package, which is specifically adapted to their requirements and has more favourable conditions than those applied to the present EU Member States. The amount available for the ten countries was fixed at Euro 5.1 billion for 2004-2006. Direct aids for the new Member States will be phased in over ten years. They will thus receive 25 per cent of the full EU rate in 2004, rising to 30 per cent in 2005 and 35 per cent in 2006. Poland won the right to make early use of Euro 1 billion of the EU money that had been allocated to it for structural instruments, so it can bridge any gaps in its national budget from topping up direct payments to its farmers.



#### The interpretation is a second second

Candidate countries have submitted their second Pre-accession Economic Programme (PEP). The objectives of the PEPs are to identify the appropriate economic policies and reforms needed to prepare for EU accession, and to develop the institutional and analytical capacity necessary to participate in the multilateral surveillance procedures of EMU upon accession. #### Commission appoints expert group to study consequences of enlargement

Next year the European Union expects to sign a Treaty of Accession with ten future member countries. Its ratification will be accompanied by a wide public debate - which has already commenced - on the implications and challenges of the extension of the EU to 25 members. The European Commission considers that an independent high-level report on the consequences of enlargement should now be made, to inform and accompany the debate. Although a number of studies have been published in recent years, a comprehensive analysis, at the European level, is desirable to provide clear and authoritative answers to the many questions, which are posed by the public. Mr Wim Kok, former Prime Minister of the Netherlands has agreed to chair the work of the Report. Mr Kok will be assisted by a group of eminent experts from present and future Member States and by the Robert Schuman Centre for Advanced Studies at the European University Institute, Florence. The report is expected by the end of March 2003.

#### 🛣 Enterprises in Central & Eastern European Countries

The creation of new enterprises slowed down between 1995 and 2000. Around 500 000 non-agricultural enterprises were newly registered in the CEECs in 2000. The creation rate of enterprises was about 13 per cent, after having been above 19 per cent in 1995 and 1996. It differed considerably across countries: in 2000, it was above 20 per cent in Estonia and Latvia and below 10 per cent in Lithuania and Slovenia. In September 2001, the survival rates of enterprises active in January 1995 in the CEECs ranged from 26 per cent in Lithuania to 67 per cent in Slovenia.

Statistical Yearbook of the EU Regions – A tool for analysing regional differences This publication sets out some general socio-economic data: population, GDP, labour force and unemployment. It investigates in greater detail certain economic sectors and some transverse economic themes. The publication also presents the indicators available for the regions of the candidate countries.

#### ☆ <u>EU Research Framework Programme</u>

The European Commission and Candidate Countries signed association agreements on the Euro17.5 billion 6<sup>th</sup> EU research Framework Programme (FP6) 2003-2006). Candidate countries will have the same rights and obligations as EU Member States within FP6. Research will therefore be the first area in which EU enlargement becomes a reality.

The Commission adopted 11 December a broad set of measures with a view to improving the decision-making in the European Union within existing Treaties. At the same time the Commission presented a report concerning progress achieved on this area since July 2001 when the White Paper for European Governance was issued. Taking into account the recently decided measures



on "Better regulation "the Commission has now fulfilled most part of its commitments undertaken in the White Paper.

#### ★ European Convention

The Commission has presented a communication to the Convention on the institutional architecture of the future Union. This contribution that is entitled "For the European Union, Peace, Freedom and Solidarity", suggests the simplification of the method of running the EU and growth in its efficiency.

The Commission plans for some innovations (appointment, responsibility) and suggests the generalisation of the methods of co-decision and the abolition of the unanimous vote. It would like to provide the Union with a single voice in terms of international policy but it is opposed to appointing a President of Europe.

#### Social Economy in CEEC

The first conference of Social Economy in Central and Eastern Europe was held in Prague, 24-25 October. The aim of the conference was to promote the recognition of social economy in CEEC and encourage a dialogue between its institutions in East and West. The outcome of the conference was the constitution of a working group identifying funding sources for social economy enterprises. Mr. Francesco lanniello, in charge of Social Economy within DG Enterprise of the European Commission proposed that the working group be open also to the various DGs of the Commission.

# European Economic and Social Committee

The first European Seminar on Social Economy and Disability was organised in Brussels on 22 November by the European Economic and Social Committee, in close co-operation with CEP-CMAF (European Standing Conference of Co-operatives, Mutuals, Associations and Foundations). The main purpose of the seminar was to raise awareness on disability issues in the social economy sector, particularly in view of 2003, the European Year of People with Disabilities.

# Consumer Co-operatives International - CCI

# ☆ Health

At its meeting in Lisbon, the International Health Co-operative Organisation of ICA (IHCO) agreed to the ICA Gender Equality Committee's proposal to hold a joint seminar in Oslo in conjunction with the ICA General Assembly next September. The Seminar will have a double focus, the first part would discuss health co-operatives as a form for providing quality health and social care services to women and men, while the second part would address the HIV/AIDS epidemic around the world.

# ☆ Housing

A memorandum of understanding was signed by a number of ICA Housing members to form a "Housing Development Consortium" with the aim of pooling experts and funding for housing cooperative projects as well as co-ordinate existing activities for a more effective use of resources for housing development.
