Co-operatives in Indonesia affected by latest earthquake

The recent earthquake which struck central Indonesia near Yogyakarta has left a death toll approaching 6,000 and with tens of thousands more injured and left homeless. Visits to two of the world's largest co-operative movements

I don't suppose you can visit two more important countries than USA and China. But that is where I have been in the last month -- indeed only one week separated the two visits.



These days what you notice most I think, are the similarities as opposed to the differences. Indeed the main difference now is, I suspect, the physical size of people - a question of diet perhaps! But in both countries there is a recognisable vibrancy in the streets where economic and social progress is clearly evident. And this is reflected in the co-operative movements as well with both the American and Chinese movements in good heart.

In the last *Digest* I emphasised the slogan co-operatives mean business and this is what describes what is happening in these two countries. We are working closer and closer with our American colleagues particularly in the areas of increasing membership and providing more relevant services to those members. One of the most impressive parts of the American movement is the sheer size of the co-operative share of the utilities market. That I hope is going to translate into a new energy/environment

sector for ICA -- perhaps the one area of activity which is currently lacking in our structure. For many people this is the main activity which we should be emphasising. The Americans are also very inter-

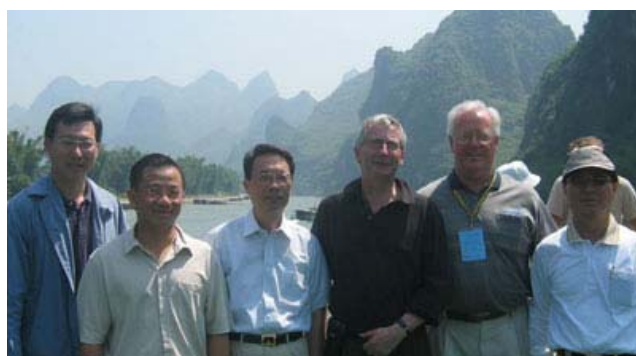
ested in working with us on the **Global 300** project and the idea of bringing CEO's together on a regular basis as we did in Italy last month.

And that is where the Chinese come in. They are no less interested in our business oriented approach, indeed possibly more so. Nowhere is there a more dramatically growing economy and it is very important that we help our Chinese colleagues in building the co-operative movement especially at a time when many state enterprises are moving to the private sector. Given the Chinese government's commitment to market socialism, it seems to me a very fertile time to emphasise the special role that co-operation can play and shows how cooperative enterprise can provide all the commercial acumen which the private sector provides - without forgetting the social aspect which is not exactly the forte of that sector! Speaking at the International Agriculture Co-operation Economic Conference organised by our

friends in the All China Federation of Marketing and Supply Co-operatives in Wuxi, I emphasised that very point. Along with an exhibition on modern agricultural methods, this conference fitted in very well with the UN/ILO/ICA expert group meeting on co-operatives and employment in Shanghai. My contribution emphasised the importance of linking with the WTO and influencing its policies from a co-operative point of view. Other contributions were from China, New Zealand and India.

So I would suggest the next CEO forum should be in China! There will be no difficulty in persuading our American colleagues of the importance of the Chinese market, and I suspect that would apply to many other members.

There is no doubt that the Chinese and US co-operative movements mean business!

ICA Board

Washington Board meeting

The most recent ICA Board was held in Washington, DC, USA on 3-4 May 2006.

Regionalisation was again the main focus of the meeting. A special report on the main decisions relating to regionalisation is provided opposite on page 5.

The work of the Regionalisation Working Group and the Governance Working Group are closely related.

We report on the forthcoming special Board strate-

gic planning meeting in Stockholm in September. The Governance Working Group will be responsible for organising this special meeting, see its report below.

A related governance matter concerns Africa. The Washington Board meeting included a report on possible future options for ICA's African region. We carry a separate report on this.

A range of other matters were also decided or noted at the meeting including:

- Mu Li is standing down as ICA Vice President for Asia, see related report on page 7.
- The ICA President sent a letter to the Brazilian parliament with regard to a possible threat to co-operative legislation.
- A discussion on co-operative legislation will take place at the Board in December 2006.
- Pauline Green was re-elected as one of ICA's

representatives on the Dotcoop board (DCLLC).

- A President's Committee meeting will be held before the end of July 2006.
- A special report will be given to the next meeting on the **Global 300** project.
- The audited accounts for 2005 were approved and the report for the first quarter 2006 was noted. The Board also agreed to investigate other forms of auditing standards.
- A full Board meeting would be held in Stockholm on 6-7 September 2006 following the strategic planning meeting.
- The December board meeting would be held in Trento, Italy on 7-8 December 2006.
- Several new members were approved and some requests for withdrawal were approved.

The current ICA Board is one of the busiest in recent history - it has scheduled four Board meetings this year, plus a special strategic planning meeting.

Preparations for strategic planning meeting underway

Governance

The Governance Working Group (GWG) has commenced the process of organising the ICA Board's global strategic planning meeting. It was one of the GWG's main recommendations that the global Board hold a special strategic planning meeting during 2006.

The first strategic planning meeting will be held in Stockholm, Sweden on 4-5 September 2006. The objective is to develop a common global vision, programme and strategic planning and reporting framework for the ICA. The strategic planning meeting will include representatives from the global Board, members of the GWG, sectoral representatives and senior ICA staff. The meeting will be facilitated by an external strategic planning expert familiar with the co-operative movement. Contact: Garry Cronan cronan@ica.coop

Main points agreed by Board on regionalisation

Regionalisation

The Washington Board meeting approved the report from the Regionalisation Working Group (RWG). In particular the RWG report contained recommendations on the four issues it was asked to consider. These four areas provide a framework within which the various constituent parts of the ICA including the Regional Assemblies to be held later this year will consider the issue of regionalisation generally, and the European situation in particular.

The Washington Board decisions provide a framework within which the constituent bodies of the ICA can further debate this issue during 2006

1. **Legal**
 - at this stage only in Europe should there be a change in legal status
 - emphasis is made on the global authority that is ICA but that each region could have its own specific identity within this authority;
 - a review of the ICA Rules and Standing Orders will be necessary to consider decisions taken at Regional Assemblies and to ensure there is one overall global legal framework into which all regions should fit
2. **Roles**
 - a very disciplined approach to be taken to prepare a successful strategic meeting in Stockholm, on 4-7 September 2006, which would also include sectoral organisations
 - that head office, regional offices and sectoral organisations should be asked to prioritise their existing roles and functions for input to Stockholm
 - to accept the agreed basis for roles and functions
 - to emphasise the role of the sectors in this exercise and to avoid competition and duplication
3. **Membership**
 - that there be two types of ICA members, full and associate, with regional and sectoral members being part of associate. Only those not eligible for full membership could normally be considered for associate
 - further consideration should be given to National Co-operative Movement and Sector/Type subscription formula options and reported back to the board
4. **Finance**
 - to operate a four-year multi-annual planning process, with a strategic budgetary review every two years. Annual budgets would continue to operate within that process
 - to continue with a revised solidarity system
 - to collect global subscriptions centrally by head office and in close association with regions and possibly sectors

The Governance Working Group is continuing with its survey of members on regionalisation and other governance matters.

The next steps

The ICA Board meeting also instructed the Regionalisation Working Group to give, together with the Governance Working Group, particular and immediate attention to:

- preparing statutes for transforming *Co-operatives Europe* into ICA's European region
- developing a clear proposal on membership subscription criteria
- prioritising roles and functions
- preparing recommendations on these issues to be considered by the special Board meeting to be held in Stockholm on 6-7 September 2006

Work is currently proceeding on the drafting of new statutes for *Co-operatives Europe*

International

Expert group meeting on co-ops and employment

An Expert Group Meeting (EGM) on *Co-operatives and Employment* was held in Shanghai, China from 15-19 May 2006.

It was organised by UN/DESA and ILO, and hosted by the All China Federation

Ivano Barberini, ICA President, spoke of the need for greater vigilance as “we are in the marketplace” being shaped by globalisation, hence the active role of co-operatives in job creation and in contributing towards fair globalisation is essential.”

As a matter of fact, co-ops have created more jobs as compared to many large corporations worldwide, but we need to focus more on creating jobs for the poor and the dis-

vantaged. Mr. Barberini also chaired one session on the Focus Group Discussions Roundup, alongside Donald Lee from UN/DESA.

Focus Groups were formed to discuss four key issues, namely (a) Co-operatives, Job Creation in Rural and Urban Areas, including the Informal Economy, (b) Co-operatives and Fair Globalisation, (c) Co-operatives and Equal Employment opportunities for Indigenous Peoples, Women and Youth, and (d) Co-operatives and Job Creation in Post-Conflict and Crisis Situations.

Various case studies were presented. The Mondragon

case study on large industrial co-ops on the one hand, and social co-operatives in Italy on the other, are examples of how sharply distinctive co-operative sectors can be in serving communities in need.

Mr. Li Chunsheng, Vice President of ACFSMC addressed the meeting explaining the historical mission of co-ops in employment promotion and protection.

He emphasised the unique advantages of linking farmers with the market, and the countryside with the cities, through which the ACFSMC unite farmers as producers and promote and defend rural employment.

Robby Tulus, ICA special envoy (post-Tsunami in Aceh) presented case studies on Indigenous Peoples' Co-operatives in the Philippines and India. He spoke about the complexity of human-induced conflicts and post-disaster environments, and how indigenous peoples are potential contributors to the local economy by forming strong self-reliant co-operatives.

Recommendations on specific issues discussed in the four focus groups, as well as the distinct roles of partners will shortly be published and circulated by the ILO.

Over 40 experts/participants attended from Bangladesh, China, India, Indonesia, Iran, Japan, Malaysia, Mongolia, Philippines, Singapore, Sri Lanka, Thailand, Vietnam, Egypt, South Africa, Argentina, Brazil, Czech Republic, Italy, Spain, USA, Canada, and five international organizations, namely UN/DESA, ILO, FAO, ICA and WOCCU.

Dr Ian MacPherson in his paper to the conference stated “co-operative contribution to job creation and community development is often underestimated and taken for granted”.

Fight global poverty – renewed call to action

160 delegates from 80 countries agreed to a new Call to Action against Poverty for 2006/07 at the Future of GCAP (Global Call to Action Against Poverty) recent meeting in Beirut.

Delegates agreed to pressure governments to eradicate poverty, dramatically

lessen inequality, and achieve the Millennium Development Goals. The core demands of the new campaign are: public accountability; just governance and the fulfilment of human rights; trade justice, a major increase in the quantity and quality of aid and financing for develop-

ment; debt cancellation and gender equality.

It was also agreed to have one global joint mobilisation in 2006 - a month of action starting on 16th September and culminating in the White Band Day on October 17th.

ICA Asia-Pacific Standing Committee Meeting

Regions: Asia-Pacific



The ICA's Asia-Pacific Standing Committee met in Wuxi, China on 16 May 2006.

Members from China, India, Japan, Malaysia, Philippines, Singapore and Sri Lanka attended the meeting which was chaired by Mu Li, ICA Vice President and Chairperson of the Standing Committee.

The meeting congratulated Seah Kian Peng, a member of the Standing Committee who has recently become a Member of Parliament in Singapore.

The Committee considered

a report from Iain Macdonald on the Regionalisation Working Group which was adopted by the recent Washington Board meeting, see report page 5.

Among other matters discussed were the future development of the ICA's Business Office in Singapore.

A youth delegate was invited to attend the Standing Committee. Teo Say Hong, from Singapore expressed thanks on behalf of the youth network for the invitation. He appealed to the Standing Committee members to send at least one

youth delegate to the next Youth Conference to be held in Colombo on 15th August 2006. He then presented the draft Constitution of ICA Committee on Youth Co-operation for Asia-Pacific which was subsequently adopted with some minor changes. It will now go to the forthcoming Asia Pacific Regional Assembly for approval.

Mu Li, from ACFSMC and the current ICA Asia Pacific Vice President advised the meeting that he was no longer involved in co-operative matters. Li Chunsheng from ACFSMC was nominated to replace Mu Li as ICA Vice President.

Regions: Europe

Expanding .COOP brand in Europe

Cooperatives Europe is progressing a development platform for the promotion and use of the dotCOOP domain name.

A common understanding was reached at a recent meeting of potential partners of the development platform, that dotCOOP should be a strategic tool for enhancing the visibility and image of co-operative enterprises across Europe.

It was further agreed that any future development platform would have two distinct features – 1) political promotion and 2) the

commercial promotion of allied IT products or services. The partners would have the prime responsibility for the implementation and realisation of the platform's development programme. The platform will have its own legal identity and will establish network groups for back-office administration for the selling of domain names, the political promotion of the dotCOOP brand, and the development of commercial IT products and services.

The platform will, in association with [Midcounties Co-operative](http://www.midcounties.co-operative) become a virtual



reseller of the dotCOOP domain name for the European region.

Pilot national reseller programmes will be implemented this summer in the Czech Republic and in the Andalusia region of Spain.

ICA Board establishes a Commission for Africa

At its recent meeting in early May in Washington, the ICA Board decided to establish a Commission to oversee the restructuring of ICA in Africa. The Commission is a sub-committee of the Board.

The decision to establish the Commission was reached after a discussion of a report on the ICA in Africa.

The report and the decision

should be seen in the context of the current process of regionalisation of the ICA.

The Commission will propose recommendations aimed at improving services to members and the development of co-operative enterprise in Africa. In addition to reviewing the current role, function and structure of the ICA in Africa, the Commission should also review the resources required to fulfil

its statutory role, to retain a meaningful members service delivery, to remain a relevant development partner and contribute to the empowerment of co-operatives in Africa. The work of the Commission has already started with a planning and review meeting recently held in Nairobi. The Commission will report to the General Assembly in Singapore in 2007.



Farmers Fighting Poverty Conference in the Netherlands

On 31 May and 1 June, ICA will participate in a conference in Arnhem organised by Dutch Ministry of Foreign Affairs.

The theme of the conference is "[Farmers Fighting Poverty](#)". Agriterra is a Dutch organisation whose goal is to promote, facilitate and support lasting co-operation linkages between rural peo-

ple's organisations in the Netherlands and in developing countries. Agriterra co-operates with rural people's organisations in Africa, Asia, Latin America and Central and Eastern Europe.

Development co-operation does not occur through governments or intermediaries, but is direct: from farmer to farmer, from rural woman to

rural woman, from co-operative society to co-operative society. ICA's regional office for Asia-Pacific is currently implementing a programme funded by Agriterra on strengthening agricultural co-operatives in Vietnam, Laos and Cambodia.



Peace

Conference on co-operatives and peace, University of Victoria, BC, Canada 18-20 June



The British Columbia Institute of Co-operative Studies (BCICS) and ICA will co-host an international workshop and conference exploring the theme: *Co-operatives in the Pursuit of Peace*.

Presentations will examine the role of co-operatives in promoting social cohe-

sion at the international, national, and local level. ICA President, Ivano Barberini, and Director-General, Iain Macdonald, are amongst co-operative leaders from around the world speaking at the event.

The conference has been limited to 35 participants to ensure adequate time for discussions and the preparation of recommendations on how co-ops can contribute to more peaceful relations

within communities and across nations. Organisers expect to prepare a number of publications from this event. Post Tsunami Interventions in India completed in record time

One of the greatest challenges for the ICA Asia-Pacific (ICA AP) in 2005 was to face the destruction caused by the Tsunami in India, Indonesia and Sri Lanka.

The ICA at global, regional (Asia-Pacific) level along with partner organisations sought, with the generous help of donations from members, to address the needs of co-operatives affected by the tsunami.

ICA AP in collaboration with the national apex co-operative organisations in India, Indonesia and Sri Lanka carried out an in-depth study of the damages caused by tsunami and provided technical support in designing co-operative reconstruction and empowerment projects in India (co-operatives in Cuddalore and Vellupuram districts in Tamil Nadu and Nicobar in Andaman Nicobar Islands with the financial support

Lanka (co-operatives in Southern Province with the financial support of B'nai Brit World Centre and the American Jewish Committee through NISPED, Israel).

The one year project in India started in July 2005 after ascertaining the needs of the target co-operatives in Tamil Nadu (need assessment jointly carried out by Anil Singh, ICA Domus Trust, Dr Puyalvannan, Principal, ICM, Chennai under the leadership of Dr Kannan, Registrar of Co-operatives, Govt. of Tamil Nadu) and Nicobar Island (as advised by NCDC). The focus was on reconstruction of co-operative physical infrastructure so as to bring back the delivery of normal services of the identified seven co-operatives for their more than 15,000 affected members.

**Co-operatives slow to
adopt ICT - Daily**

As reported on the front page of this issue, the ICA has launched a new "news" service.

The objective is to bring together in one site all the news from and about co-operatives.

One of the constant con-

cerns expressed by ICA members and others is the lack of profile for co-operatives in the media.

This is the case, although there is nevertheless, a large amount of co-op news which does get reported, or released by co-operatives themselves. By bringing this news and

information together in one spot it is hoped that we will be better able to see trends and issues of concern to co-ops at a much earlier stage.

We will then be able to either respond in the media or act in other ways on this "market intelligence", information which has previously gone unnoticed or acted upon.

Two streams of co-op news: one from co-operatives and one from reports in the media

The new website www.icanews.coop is drawing its content from two main sources.

Firstly, from co-operatives themselves. We will be encouraging co-ops and other related organisations to provide RSS enable feeds, so our website will be able to automatically publish your latest news. This, we believe, will provide a wider audience for your news.

Secondly, we are using search engines to hourly trawl the internet for the latest news on co-operatives.

In effect we are bringing together what co-ops are saying about themselves and what the external media is saying about co-ops.

It is hoped this mix of news from these two sources will enrich each other and be of value to members.

How does www.icanews.coop work?

The new "news" site has been developed using Drupal open source software.

As noted above, it is receiving two main streams of information.

It is expected that over time these two streams will generate potentially hundreds of news feeds a day. To help make

sense of this information, we are developing a menu system which gives you a way of searching for exactly what you want.

This menu system will take some time to fully develop, however at this stage we will be offering you the chance to search the news by date, region or country, sector or issues, for example demutualisation.

The news site will take several months to become fully operational and reach its full potential, so be patient!

Several other new features are planned for this site over the coming months including a members only section and new pages featuring best practices for co-ops.

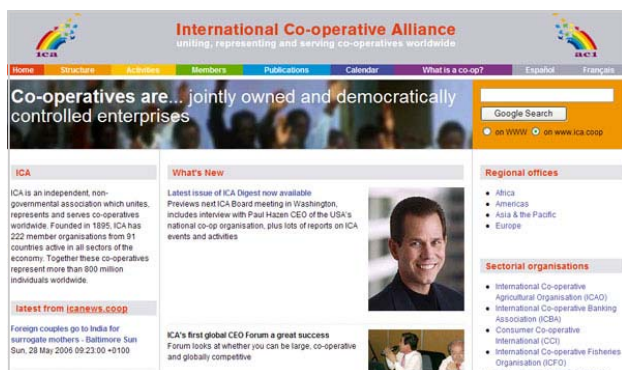
The ICA was one of the first co-operative organisations to establish a website well over a decade ago.

WOCCU journal highlights increasing merger activity

There are a number of Credit Unions from throughout the world in the draft Global 300 list the ICA has prepared.

The latest issue of WOCCU's newsletter *World* also focuses on the merger trend which is evident among credit unions, but more generally among co-operatives as they seek to survive in increasingly competitive markets.

It notes that similar merger trends are occurring in three countries with strong Credit Unions, the USA, Canada and Australia. However, it states, "mergers may be making it possible for credit unions to survive, but they don't appear to be fuelling much membership growth in any of these movements". It also notes that the vast majority of credit union mergers in these countries are voluntary, not failures or demutualisations.

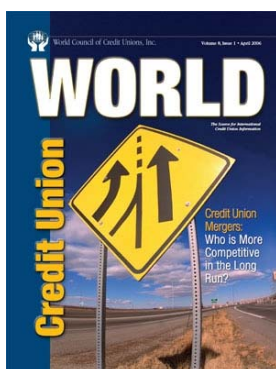
ICA reaches agreement with USA co-operative organisations to share data for Global 300 project

New brand - promoting “the co-operative” in the UK

Branding

Zoe Morgan, Director of Marketing at the Co-operative Group www.co-op.co.uk/ explains the thinking behind a new identity for the UK’s ‘the co-operative’ brand.

For many consumers in the UK the word “co-op” has lost its meaning. Especially amongst younger people, “co-op” is simply the name of a grocery store made up of four letters. How to turn this situation around and re-invigorate the

– ‘The co-operative’ with simple but descriptive business names – for example ‘The co-operative travel’ ‘The co-operative pharmacy’. This is all geared to making ‘The co-operative’ a focal point of the signage, using the same font and blue colour across all our business sectors. Each business sector is differentiated by use of a different background colour linked to that business activity.

Five key brand messages have also been developed

to give a new co-operative identity we have developed standards of customer care including the condition of the outlet that carries the co-operative brand, customer service provided, products offered and crucially, availability.

To test the brand, we trailed the new identity in over 40 co-op branches across the UK. We measured performance in these



whole co-operative brand in the UK is the objective of a brand panel, established in the wake of the Report of the Co-operative Commission at the beginning of the millennium.

Following extensive consultation, a new identity based on ‘The co-operative’, was developed. The brand has been subject to the most rigorous programme of research ever conducted in the history of the business. A new fascia system was created which uses the umbrella brand name

– ‘championing’, ‘consistent quality’, ‘trustworthy’, ‘rewarding experience’, and ‘community’. The communications package that underpins the new brand, delivers these messages clearly to all stakeholders. By using the words ‘The co-operative’ we are making a statement about the organisation and the way we do business – “straightforward, open and honest”.

Of course, there is far more to creating a brand than a new fascia. In parallel with the work to de-

pilot locations through trading results, customer numbers and consumer research. Initial results indicate that there is strong support for the new brand amongst customers and staff.

Given the positive results of the trial, The Co-operative Group has decided to rollout the new identity across more than 3,400 outlets in the UK, with the benefit of strengthening the links between our businesses and promoting the advantages of co-operative trading.

“The UK experience of re-branding “the co-operative” could have relevance for many other movements throughout the world.

IFAP Congress adopts global farmers’ charter

Agriculture

The recent International Federation of Agricultural Producers (IFAP) 37th World Congress adopted a global farmers’ charter proposed by Korea’s National Agricultural Cooperative Federation. The 10-point charter includes protection and support for poor farmers and balanced development of rural and urban areas. It also stresses the status of farmers as producers of safe food and calls for co-operation between farmers’ groups to improve their social and economic position. IFAP will work to have the charter adopted as a UN resolution.

Feature interview

Alban D'Amours

This month the **Digest** talks to ICA board member, Alban D'Amours. Mr D'Amours is President and CEO of [Desjardins Group](#), the largest integrated co-operative financial group in Québec, Canada. He is a passionate defender of the co-operative business model and here discusses his vision for a more outspoken and proactive global co-operative movement.

Digest: How did you get involved in the co-operative movement?

AD'A: First of all, my academic background is in economics, which I taught for a number of years. I have always shown an interest in regional economic development. I also participated in founding the Institut de Recherche sur les coopératives de l'Université de Sherbrooke (IRECUS, a research institute on co-operatives), at Sherbrooke University where I was Professor of Economics for twelve years.

My first real experience in co-operative management was as Chair of the Board of the Caisse des fonctionnaires de Québec for five years, when I was serving in the Québec government (as Deputy Minister of

Revenue and Associate Deputy Minister of Energy). I was later invited to play an active role in the Desjardins Group. I was thrilled to join such a well-known and important socio-economic player of Québec society. Four out of five Quebecers are members of one or more caisses Desjardins. Our group is also Québec's largest private employer with over 37 000 employees. I must say that co-operatives in Québec, generally speaking, enjoy strong support from both the population and the provincial government.

I am a keen defender of the co-operative business model. I believe in its numerous virtues, its efficiency and its relevance in today's world. It benefits local communities directly, ensuring sustainable development and employment as well as equitable wealth distribution. It is capable of reconciling both financial and humanistic goals to the highest level. Our slogan at Desjardins – "making money work for people" - reflects our belief that co-operatives can be very competitive in terms of financial and social outcomes.

Digest: What does your current work in the co-operatives sector involve?

AD'A: As a member of Desjardins' senior management since 1988, I have held various positions, including that of Inspector and Auditor General of Desjardins Group. I was elected President and Chief Executive Officer of Desjardins Group in March 2000 and re-elected for

a second term in January 2004.

I am Chair of the Board of Directors of the Fédération des caisses Desjardins du Québec, the central entity of the Group, and Chief Executive Officer of the Group and of its subsidiaries. The Desjardins Group is the largest financial institution in the province of Québec and the country's sixth largest with assets totalling over 125 billion CAN\$. Its network of over 500 caisses supported by some 20 subsidiaries serves close to 5.6 million owner-users in Canada offering them a complete range of banking and financial services. Desjardins' mission is to contribute to the well being of people and the economic and social development of their communities.

In my capacity as CEO of the Group, there are three objectives, the achievement of which is most important in my mind. They also figure amongst the Group's strategic priorities for 2006-2008. The first is the continuous search for efficiency and innovation throughout the Group. The second is to make our co-operative difference more tangible in everything we do (in our product offering, in our business relationship and in our business conduct in general, always striving to act according to co-operative values) and by acting according to co-operative values. The third is to contribute to the

growth and competitiveness of the co-operative movement.

Let me give you a few examples. Desjardins is proactive in the solutions it offers to several key societal problems, be it protection of the environment, the aging of the population impacting available manpower, succession planning and so on. For instance, Desjardins is the only financial institution in Canada which has a policy for supporting regional economic development. We succeeded in reinvigorating the economy of a small town located in a distant region by establishing our provincial student loan centre there rather than opting for a site in a major city. We supplied a new building and created 100 jobs. We contribute CAN \$5,000,000 in wages to the region each year and we are the largest private employer in that town.

Also, in the context of its Canadian expansion, Desjardins wants to play an important role in the strengthening of the financial co-operative movement. The Group is offering its technological platform and related services to other credit unions to better equip them to face the fierce competition from strong commercial banks.

Digest: *How strong is the movement in Canada and is it expanding?*

AD'A: The Canadian co-operative movement counts close to 16 million members out of a population of 32 million. It represents assets totalling \$184 billion. In the financial co-operative

sector, Canada is one of the countries which has the largest number of credit union members in proportion to its population (close to 33%). The financial co-operative sector alone accounts for 11% of the total national assets of the country's deposit-taking institutions.

One sector which is going to grow and generates much interest is that of health co-ops and home care co-operatives. In Canada, and in Québec in particular, we must prepare for the acute aging of the population.

We must however stay vigilant. Not so long ago, we witnessed, with sadness, the demutualisation of the last of three major wheat pool organisations. The spectre of demutualisation remains a threat to many of our great co-operative enterprises. Those who believe that demutualisation delivers sound outcomes must awaken to the fact that it seriously hinders in the long run the significant socio-economic benefits that mutuals and co-operatives pledge to their members and to the businesses of the local communities at stake. And in the short run, the few users of the moment will unfairly benefit from a global patrimony built by previous generations. We need to combat this idea by promoting the success of co-operatives at all levels, including among management teams which too often wrongly believe that the capitalistic model is the better one namely to access capital to ensure the

growth of the organisation.

In my view, co-operatives in Canada can play a significant role in the economy. We see more and more state governments' deficit increasing and their ability to render some services to the population at reasonable costs threatened. Co-operatives are the best partner for government to deliver services in a non-discriminatory way to the population, having its interest at heart and not being motivated first and foremost by the search for profit. Obviously, this is over and above the generous returns of moneys to local members and communities under the form of patronage allocations, sponsorships, bursaries and donations. Over the past three years, the Desjardins Group has returned over 1,2 billion

CAN\$ in patronage allocations alone to its members, equal to 41% of its surplus earnings.

Digest: *what in your view are the priorities for the movement at home and globally?*

AD'A: Intercooperation amongst co-operatives is key. For instance, a Desjardins subsidiary has created a venture capital instrument namely to help the capitalisation of co-operatives in Québec.

In the financial sector, there are great opportunities ahead. We are already preparing ourselves in the event of potential mergers amongst the larger Canadian commercial banks. Where some banks could be forced to sell off some branches, financial co-operatives could join forces to integrate those to ensure that Canadians' accessibility to financial services and quality service are preserved.

Also, at the international level, through its subsidiary Développement International Desjardins www.did.qc.ca/en/default.html technical expertise in the area of microfinance is provided to more than 800 credit unions serving three million members in some 20 emerging countries. Last week, Desjardins hosted a meeting with federal government officials from the Ministry of Finance who wanted to become more acquainted with our Group, since in Canada, co-operatives operate mainly under provincial jurisdiction. They were greatly surprised by our business perform-

ance and learned much from the various presentations over two days. It strikes me that co-operatives need to be more aggressive and outspoken about their business success and social performance. We need to make ourselves more visible at every level, amongst wider audiences. I was shocked to hear last week about the possibility of Standard's Life demutualising. We must be more convincing about what added-value co-ops can offer members and their communities.

It is a well-known fact that co-operatives' characteristics are little known by various institutions of importance, be they regulatory or supervisory agencies (rating agencies, international authorities for accounting norms, Basel Accord and so on). There is a great need at the international level to make the business case for co-operatives and to promote their success and huge contribution to local communities, to show how they can become significant partners of state governments in the fight against poverty, exclusion, or in employment creation, and how they can make a difference in the many forms of return they make to the local communities rather than profits that return to foreign investors.

To do that, we need updated data – the only way we can really appreciate the success, financial and social, of co-operatives. We hope that the HEC

international financial co-operative observatory (part of the University of Montreal) will remedy, in part, this situation. The ICA Global 300 project is an example of an initiative to help promote the co-operative business model. We need economic indicators and financial ratings to hand. Global data is not available. This is a very serious problem.

We must also monitor the evolution of the co-operative movement. Are there more co-operatives now than 10 years ago? What are the characteristics and business models of successful co-operatives? What are the key trends affecting co-ops and how can we better anticipate the issues likely to shape and ensure their future? The movement needs to find answers to the questions and to access reliable data.

The ICA also has a role to play in ensuring the co-operative model is more visible at a global level. All of us working in the co-operative movement need to be aware of the threats from the dominant capitalist model. Governments at all levels are very influenced by this model. All the regulations we have to work within derive from this model. The co-operative movement has a lot of work to do and we can do it more effectively by working together – creating networks. Even though this requires that we must reconcile solidarity and autonomy, it is the only way to meet the challenges ahead.

TICA at the World Congress on Social Tourism

Sectors

Tourism co-operatives joined the International Bureau of Social Tourism in Aubagne, France to discuss and share best practices.

Under the theme, *Towards a tourism based on development and solidarity*, 280 participants including members of TICA, ICA's sectoral organisation for tourism, discussed issues for how to improve access to all to holidays, how social tourism contributes to regional development and how fair tourism can contribute to the reduction of poverty.

TICA Coordinator and

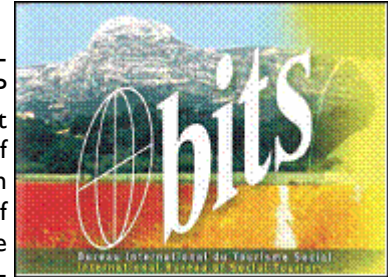
BITS Board member, Maurizio Davolio, helped organise and acted as rapporteur on the session on fair tourism and poverty reduction.

Two UN agencies, the United Nations World Tourism Organisation (UN WTO) and the United Nations Development Programme shared information on tourism projects that aimed at community development. Both underlined too the important role that co-operatives played in their actions to promote sustainable development.

During the discussions, Mr. Eugenio Yunnis of UNWTO noted, "the co-operative ele-

ment is vital for the success of sustainable community development and reducing poverty".

Ms. Nesma Brahimhi of UNDP also noted that the creation of co-ops were an integral part of rehabilitating the ancient commercial route of Ksour to both protect cultural heritage in Sahelian Africa and create income opportunities for the local population. TICA and ICA will be following up with both organisations on how to work more closely together.
